Considerable reliance is placed on the exporters/importers and their agents submitting correct codes and information. Before the data is released for statistical purposes it is validated and detected errors corrected.

All overseas merchandise trade data is provisional for three months, and is therefore subject to change until finalised. Where this report contains such provisional data, we will advise the existence of the provisional data.

Information relating to GDP growth, GDP Per Capita, Economic Rankings and Groupings and Household Disposable Income have been sourced directly from The World Bank, and imported into this report. GDP Growth, GDP Per Capita are as at 2015. Economic Groupings and Regions are correct as at March 2017. Information relating to Household Disposable Income was retrieved from the World Bank in June 2017.
